SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

If irritation is experienced, remove person to fresh air.

Skin Contact

Increase ventilation to area or move leaking container to a well-ventilated and secure area. Eliminate all ignition sources. Use grounded, explosion-proof equipment. Wear splash proof goggles, chemical resistant gloves and rubber boots. Do not allow contact with clothing.

Wear a NIOSH approved air-purifying respirator with an organic vapour cartridge.

Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway.

If the spill is inside a building, prevent product from entering drains, ventilation systems and confined areas. Minimize the use of water to prevent environmental contamination.

Methods and Materials for Containment and Cleaning Up

Place used absorbent into suitable, covered, labelled containers for disposal.
